CIRCULAR

Subject: Regarding Pre-Matric scholarship scheme and Post-Matric Scholarship scheme for Minority students for the year 2021-22 (Central Sector Scheme) on National Scholarship Portal 2.0 (NSP).

In continuation of preceding circulars dated 21.10.2021, 28.10.21, 02.11.21 & 16.11.2021 on the subject cited above all HoSs are informed that the timeline for various activities under Pre-Matric scholarship scheme and Post-Matric scholarship scheme for minorities students on NSP has been changed by the Ministry of Minority Affairs, Govt. as under: -

1.	Online Application for Pre-Matric and Post-Matric Scholarship Scheme	15 th December, 2021
2.	L 1 Verification (INO Level)	31 st December, 2021
3.	L 2 Verification (DNO/SNO/Ministry level)	15 th January, 2022

All Head of Schools of all Govt., Govt. aided, recognized private unaided schools and local body schools are advised to make well aware the minority students and guide them so that eligible students can apply in time i.e. before **15th December, 2021**. Further, all Head of Schools are requested to expedite the verification process to make **"Nil" pendency for verification of applications** in school login instead of waiting for last date for verification.

At last, it must be noted that all type of schools having UDISE Code must be KYC compliant and their INO must be Aadhaar Authenticated on NSP of Govt of India. In case, this instruction is not complied with then minority student of concerned school cannot apply for Pre/Post matric scholarship on NSP and their INO will not be eligible for online verification of online applications on NSP.
