Sub: Sponsorship for allotment of land to Mata Phoolan Wanti Ednl. Society for establishment of Sr. Sec. school in Pappan Kalan or anywhere in the educational zone XXI of District S.W.-B within the validity period of E.C. i.e. 07.12.2002

Sir,

I am directed to state that the Land Allotment Committee constituted by the Hon'ble Lt. Governor has considered and recommended allotment of land to Mata Phoolan Wanti Ednl. Society for establishment of Sr. Sec. school in Pappan Kalan or anywhere in the educational zone 21 of District S.W.-B within the validity period of E.C. i.e. 07.12.2002

While issuing allotment letter of land so recommended to the Society/Trust referred to above, it may be ensured that apart from other conditions as already prescribed by your office, the following conditions are also inserted in the allotment letter:

1. The Society/Trust must ensure that the school to be set up on the land allotted by DDA is got recognized from the appropriate authority after fulfilling the conditions of recognition prescribed under sub-section (1) of Section-4 of DSEA 1973 and the rules made thereunder. The construction of the building be carried out after approval of site plan from the competent authority.
2. It shall be the responsibility of the Managing Committee of the school to ensure the compliance of the provisions of DSEA, 1973 and the rules made thereunder. The conditions of recognition so prescribed under sub-section (1) of Section 10 of the Act read with provisions of rule 50 and 51 of the rules should be strictly adhered to.
3. D.D.A will made allotment of land subject to the E.C. being valid i.e. within the validity period of E.C.
4. The sponsorship will be valid only for the educational zone of the Directorate of Education from which E.C. has been issued and the D.D.A. will allot land to the society only in that educational zone as communicated by the Directorate of Education.
5. I am further directed to request you to send a copy of letter of allotment in case of the allotment of land to the said society.


1. North - Saraswati Model School
