**ORDER**

**Sub: Scheme of Assessment for Classes IX & XI for the Academic Session 2021-22**

The need of the hour is that the students are able to think scientifically, mathematically or artistically to face the real life challenges in an information and technology driven world and enhance their inherent potential. The exceptional circumstances of COVID-19 Pandemic led to the closure of schools for a long period without face to face class room interaction of student & teacher.

Directorate of Education, Govt. of NCT of Delhi has already endorsed the Special Scheme of Assessment issued by CBSE vide circular No Acad-51/2021 dated 5<sup>th</sup> July, 2021 for Board Examinations of classes X & XII. To implement the same for the students of classes IX & XI for the Academic Session 2021-22, Special Scheme of Assessment as given below is in continuation of earlier order No DE.5/212/ Exam/16-17/1373-81 dated 09/10/2019 titled "Strengthening Assessment & Evaluation Practices and Promotion Policy of classes IX & XI with effect from the Academic Session 2019-20".

**1. Scheme of Assessment & Evaluation Practices**

- (a) Academic Session will be of two Term Examinations i.e. Mid Term Examination (Term-1) & Annual Examination (Term-2) with approximately 50% syllabus in each term.
- (b) Question papers in Mid Term Examination (Term-1) shall have Multiple Choice Questions (MCQs) including Case Based & Assertion Reasoning Type. The duration of the examination will be of 90 Minutes. Mid Term Exam will be conducted in the month of October/November for classes IX & XI.
- (c) Question papers in Annual Examination (Term-2) shall have descriptive questions i.e. Case Based/ Situation Based, Open Ended – Short Answer/ Long Answer Type Questions. The duration of the examination will be of 02:00 Hours and question papers would be set out as per design of question paper of CBSE. Annual Examination will be conducted in the month of February/March for classes IX & XI.
- (d) Marks of Mid Term Examination (Term-1) & Annual Examination (Term-2) and Internal Assessment/Practical/Project Work/Assessment of Listening & Speaking would contribute to the final overall score out of 100 marks in each subject.

## 2(b) Scheme of Assessment for Internal Assessment/ Practical/ Project/ Assessment of Listening & Speaking

Internal Assessment will be carried out as per the existing scheme across the year except that the assessment will be done twice and both will contribute equally in overall assessment. The evaluation done by teachers for internal assessment/practical/project work needs to be based on evidence of the student's performance throughout the



academic session. Some important modifications in the scheme are given in the table below:



For Subjects with Practical of 30 marks:</b></p> <p>a) Practical work would be divided into 02 terms (as detailed in the Term-wise curriculum for the purpose of examination)</p> <p>b) Students would be undertaking the practical work of Term I and II in the respective terms</p> <p><b>Term I:</b> 15-mark Practical (as detailed in the curriculum) would be conducted under the supervision of subject teacher. <b>Or</b> In case the situation of lockdown continues until Nov Dec 2021, a pen and paper assessment on the basis of syllabus for practical for the first term carrying a weightage of 15 marks would be conducted at the end of Term I at the school level.</p> <p><b>Term II:</b> At the end of Term II, a 15-mark Practical would also be conducted at school level. <b>Or</b> In case the situation of lockdown continues beyond December 2021, a pen and paper assessment on the basis of syllabus for practical for the second term carrying a weightage of 10 marks and Viva for 5 marks would be conducted at the end of Term II by the school.</p>
<p><b>Subjects with Project Work, Assessment of Listening and Speaking Skills</b></p>	<p><b>1.Subjects with Project Work of 20 marks:</b> Economics, Business Studies, Accountancy, History, Political Science, Sociology, Legal Studies etc</p> <p>There would be only ONE project for the session. The project work would be divided into two parts i.e. Term I (10 marks) and Term II (10 marks).</p> <p><b>2. Subject with Project Work of 30 marks:</b> (Entrepreneurship) There would be only ONE project for the session. The project work would be divided into two parts i.e., Term I (15 marks) and Term II (15 marks).</p> <p><b>3. Subjects with Assessments of Listening and Speaking Skills: (All Languages)</b></p> <p><b>Term I: Scenario I</b> - if it is possible to conduct in person assessment of Listening and Speaking Skills (10 marks) will be done in person by subject teacher.</p> <p><b>Scenario II</b> - If schools remain closed Assessment of Listening and Speaking Skills (10 marks) will be done online by subject teacher.</p> <p><b>Term-2:</b> Assessment of Project and Viva based on the project work will be done by subject teacher. (10 marks). Project can be in the form of a neighborhood survey/Role play performance (individual/group) etc. (Online or in-person as situation allows). Students shall submit a project report (5 marks) and Viva voce (5 marks) shall be conducted by subject teacher.</p> <p>Assessment of Listening Speaking guidelines are given at Annexure II and also provided along with respective language curriculum by CBSE</p>
<p><b>Other Subjects</b></p>	<p>In both the terms, practical will be conducted either online or in-person, (if situation allows), by the subject teacher. (Kathak Dance, Bharatnatyam Dance, Kuchipudi Dance, Odissi Dance, Manipuri Dance, Kathakali Dance, Hindustani Music (Melodic), Hindustani Music (Vocal), Hindustani Music (Percussion), Painting, Graphics, Sculpture, Applied Art Commercial Art, Carnatic Music (Melodic), Carnatic Music (Vocal), Carnatic Music (Percussion)</p> <p>Term I and II: Internal cum Practical work of 35 marks in each Term (For details, refer to the respective subject curriculum)</p>


