CIRCULAR

Sub: To prepare a 100 days plan to improve the usage of Aadhaar in various areas/departments in Delhi for making Aadhaar as a system of inclusion by Organizing Camps for 0-5 age group of children and get the Mandatory Biometric update done for the age group of 5 & 15-reg.

In continuation to earlier Circular of Even Number dated 16/02/2023 and as you are aware, Aadhaar number is being asked from school children for availing admissions obtaining scholarships, attending various Board and other examinations, participating in various competitive examinations. It is therefore necessary on schools to provide Aadhaar enrolment and biometric update facilities to students without causing any hardship to them or their parents.

2. Also, mandatory update of Biometrics in Aadhaar is also required for children on attaining the age of 5/15 years to ascertain validity of their Aadhaar number assigned earlier.

3. Further, in the Minutes of UIDIC meeting dated 09.01.2023 held on 10.11.2022 under the chairmanship of worthy Chief Secretary, Govt. of NCT of Delhi and vide letter dated 07.02.2023 (copy enclosed) it has been emphasized to improve the usage of Aadhaar in various areas/departments in Delhi and to prepare a 100 days plan wherein Aadhaar is a system of inclusion and not Exclusion.

4. For children who are not yet assigned an Aadhaar number or whose biometrics in Aadhaar database is not updated, it shall be the responsibility of the schools under Regulation 12A of Aadhaar (Enrolment and Update) Regulations to arrange to provide for Aadhaar enrolments and biometric update of such students. This should be facilitated by the schools by organizing special camps for 0-5 age group of children and get the Mandatory Biometric update done for the age group of 5 & 15 years in their premises.

5. In order to avoid any hardship to children in availing the benefits or other purpose as mentioned above for want of Aadhaar, it is obligatory to district school administration to organize Aadhaar enrolment camp in all the schools, by making school-wise roster for the same or through HoS concern at school level. In order to augment the effort in organizing enrolment camp, the District Administration/School may also coordinate with the agency empanelled for Aadhaar/Biometric updation for schools children Le. M/s GG Staffing Solution & Consulting Pvt. Ltd. to organize camp in nearby schools.

6. All RDE/DDE/HOS of the schools are therefore, directed to take necessary requisite actions to achieve the above stated goals within the time frame of 100 days for making Aadhar as a system of inclusion in Delhi under intimation to the Directorate of Education.

7. This issues with the prior approval of the Competent Authority.
